VOLUNTEER RELEASE AND WAIVER OF LIABILITY FORM

This Release and Waiver of liability (the “release”) executed on _____ (date) by _____ (“Volunteer”) releases Mesa Grande Business Development Corporation (“Corporation”), a tribally chartered corporation organized and existing under the laws of the State of California, and Mesa Grande Band of Mission Indians (“Band”) and each of its directors, officers, employees, and agents. The Volunteer desires to provide volunteer services for Corporation and engage in activities related to serving as a volunteer.

Volunteer understands that the scope of Volunteer’s relationship with Corporation is limited to a volunteer position and that no compensation is expected in return for services provided by Volunteer; that Corporation will not provide any benefits traditionally associated with employment to Volunteer; and that Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of Volunteer’s services to Corporation.

1. Waiver and Release: I, the Volunteer, release and forever discharge and hold harmless Corporation and its successors and assigns from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from the services I provide to Corporation. I understand and acknowledge that this Release discharges Corporation from an liability of claim that I may have against Corporation with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to Corporation or occurring while I am providing volunteer services.
2. Insurance: Further I understand that Corporation does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of Corporation beyond what may be offered freely by Corporation in the event of injury or medical expenses incurred by me.
3. Medical Treatment: I hereby Release and forever discharge Corporation from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment of other medical services rendered in connection with an emergency during my tenure as a volunteer with Corporation.
4. Assumption of Risk: I understand that the services I provide to Corporation may include activities that may be hazardous to me including, but not limited to _____ involving inherently dangerous activities. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and Release Corporation from all liability.
5. Photographic Release: I grant and convey to Corporation all right, title, and interests in any and all photographs, images, video, or audio recording of me or my likeness or voice made by Corporation in connection with my providing volunteer services to Corporation.
6. Other: As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of California and the laws of the Band and that this Release shall be governed by and interpreted in accordance with the laws of the State of California and the Band. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
